APPLICATION

Applicant, **ILIGAN LIGHT & POWER**, **INC.** (**ILPI**), through undersigned office, unto this Honorable Commission most respectfully states, that:

1. ILPI is a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at Bro. Jeffrey Road, Pala-o, Iligan City where it may be served with summons and other legal processes;

- 2. It is the holder of an exclusive franchise issued by the Congress of the Philippines to operate electric light and power distribution service in the City of Iligan, Province of Lanao del Norte;
- 3. Pursuant to Commission's Resolution No. 17, Series of 2011 entitled, "Resolution Adopting the Investor Owned Electric Distribution Utility Planning Manual," Resolution No. 26, Series of 2009 entitled, "Resolution Amending the Rules for Approval of Regulated Entities' Capital Expenditure Projects," Resolution No. 20, Series of 2008 entitled, "Resolution Modifying the Rules for Setting Distribution Wheeling Rates for Privately Owned Distribution Utilities Entering Performance Based Regulation (RDWR)," Resolution No. 13, Series of 2006 entitled, "Guidelines to Govern the Submission, Evaluation and Approval of Electric Distribution Capital Projects," and other applicable laws and rules, this Application is submitted and filed for the consideration and approval of this Honorable Commission;
- 4. Under the Honorable Commission's *Performance-Based Regulation (PBR)*, ILPI is part of the Second Entry Point Group B that entered the PBR regime on April 1, 2009;
- 5. Inasmuch as the Honorable Commission has yet to issue the relevant rules for the reset process (*Third Regulatory Period covering April 1, 2013 to March 31, 2017*) for the subsequent filing of ILPI's reset application and considering that for purposes of recovering the capital costs of the project through power rates, the same shall require the evaluation and approval of the Honorable Commission. Thus, Applicant caused the preparation, submission and filing of this Application for the approval of ILPI's *Dalipuga Switching Station Protection and Metering and Lines (Republic Cement Iligan, Inc. 69 kV Outgoing Lines) Capital Expenditure (CAPEX) Project and corresponding charges and effectivity to Republic Cement Iligan, Inc. summarized hereunder, as follows:*

6. THE CAPEX PROJECT

The CAPEX Project aims to connect Republic Cement Iligan, Inc. (RCII) to ILPI's Subtransmission Network through the Dalipuga Switching Station. The project will construct a new 69kV lines from Dalipuga Switching Station to RCII and install protection, a Power Circuit Breaker and a Protection at the Switching Station. The project will also install a new revenue meter for RCII.

The CAPEX Project and its justifications are discussed in detail in ILPI's CAPEX Information Summary (CIS) together with all the necessary supporting data;
